

RESOLUTION NO. 2023-03-13-001

VILLAGE OF WAYNE LAKES
DARKE COUNTY, OHIO

A RESOLUTION OF NECESSITY FOR RENEWAL OF A PREVIOUSLY-
VOTED TAX LEVY OF 7.0 MILL FOR THE PURPOSE OF CURRENT
EXPENSES FOR THE VILLAGE OF WAYNE LAKES, OHIO AND
DECLARING AN EMERGENCY FOR THE SAME.

The Council for the Village of Wayne Lakes, Darke County, Ohio (“Council”) met in session on March 13, 2023, with the following members present:

_____ moved the adoption of the following Resolution:

PREAMBLE

WHEREAS, by Resolution 4-2016, and subsequent approval by the voters, the Village of Wayne Lakes, Ohio (“Village”) renewed a 7.0 Mill levy for additional funds for current expenses pursuant to ORC 5705.19(A).

WHEREAS, the amount that will be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of current expenses of the Village of Wayne Lakes, Darke County, Ohio; and

WHEREAS, it is necessary to levy (renew) a tax in excess of the ten-mill limitation; and

WHEREAS, the levy would be for the purpose of providing additional funds for the current expenses of the Village of Wayne Lakes, said purpose being authorized by ORC 5705.19(A); and

WHEREAS, a resolution declaring the necessity of levying said tax, pursuant to ORC 5705.03 and ORC 5705.19(A), outside the ten-mill limitation must be approved and certified to the Darke County Auditor (“Auditor”) in order to permit Council to consider the levy of such a tax and must request that the Auditor certify to Council the total current tax valuation of the Village, and the number of mills required to generate a specific amount of revenue, or the dollar amount of revenue that would be generated by a specific number of mills.

RESOLUTION

NOW THEREFORE, BE IT RESLOVED, by the Council, at least two-thirds (2/3) of all the members of the council concurring, as follows:

1. The amount of taxes that will be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of the Village.
2. It is necessary to levy (renew) a tax in excess of the ten-mill limitation.
3. Pursuant to ORC 5705.03(B)(1):
 - a. The proposed rate of the tax, expressed in mills for each dollar of taxable value, to be generated by the proposed tax is 7 mills.
 - b. The purpose of the tax is for renewal for current expenses.
 - c. The tax is a renewal of an existing tax.
 - d. The section of the Revised Code authorizing submission of the question of the tax is ORC 5705.19(A).
 - e. The term of years of the tax is five years.
 - f. That the tax is to be levied upon the entire territory of Wayne Lakes.
 - g. The date of the election at which the question of the tax shall appear on the ballot is November 7, 2023.
 - h. That the ballot measure shall be submitted to the entire territory of Wayne Lakes.
 - i. The tax year in which the tax will first be levied is 2024 and the calendar year in which the tax will first be collected is 2025.
 - j. The entire territory of Wayne Lakes is within Darke County, Ohio.

4. Pursuant to ORC 5705.03(B)(1), the Clerk of Council is hereby directed to certify a copy of this Resolution to the Auditor. The Council hereby requests that the Auditor certify to Council the following:

- a. The total current tax valuation of the Village;
- b. The dollar amount of revenue that would be generated by the levy of 7.0 mill.

5. All formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of the Board, and all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including ORC 121.22

6. This Resolution shall be and the same hereby is declared to be an emergency measure, necessary for the continued health, safety and general welfare of the residents of the Village of Wayne Lakes, Ohio, in that the same is required to promote timely submission of the issue of this tax levy to the electorate of the Village of Wayne Lakes, Ohio, and, to ensure the orderly continuation of necessary services to the residents of said Village;

7. This Resolution shall be in full force and effect immediately upon adoption.
