

**ORDINANCE 2024-12-16-002**

**AN ORDINANCE  
PROVIDING COMPENSATION FOR CERTAIN VILLAGE  
EMPLOYEES, REPEALING CERTAIN ORDINANCES, AND  
DECLARING AN EMERGENCY.**

WHEREAS, this Council desires to add the position of Maintenance Supervisor to the list of Village Employees, and to set the pay range for said position, subject to the administration of such range(s) by the Mayor.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF VILLAGE OF WAYNE LAKES, DARKE COUNTY, STATE OF OHIO:

SECTION 1. That, effective January 1, 2025, the following ranges of compensation for Village employees be and are hereby established as follows:



Grounds Crew/lakes	\$10,000/YR	\$15,000/YR
Seasonal Help	Minimum Wage	\$38.00/hr
ADMINISTRATION		
Recreation/Building mgr (including event bonus upon council approval)	\$12.00/hr	\$50.00/hr
Fiscal officer/clerk of council (including bonus upon council approval)	\$22.00/hr	\$38.00/hr

Section 2. That any ordinance or part thereof in conflict herewith be and is hereby repealed.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the Village of Wayne Lakes.

Section 4. That this ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of


the Village of Wayne Lakes, and further, this ordinance provides for establishing the titles and timely compensation of Village employees; wherefore, this ordinance shall be in full force and effect from and after its adoption and approval by the Mayor, provided it receives the affirmative vote from council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
