# COUNCIL MEETING

May 20,2025 7:00 p.m.

Mayor Clark called the meeting to order at 07:00 PM, proceeding with The Pledge of Allegiance and Invocation. Council members present: SHyatt, LPrice, JWeaver, REstes CJeffers

Agenda was approved with noted changes. Motion SHyatt, seconded JWeaver, all present voted yea Minutes: SHyatt motioned to approve the May 6, 2025 minutes. Motion JWeaver. Seconded SHyatt, all present voted yea

- Mayor read sewer project updated as provided by Brice/Access Engineering. Question regarding the shut off
  valves being placed close to the road side and risk of being ran over/hit by car due to narrow roadways, also
  limited ability to widen roads in the future. Mayor agreed to review with Brice and provided a response.

- Ordinance No 2025-04-21-2 Regulation of Peddlers and Solicitors in the Village. Motion to adopt by SHyatt. Second by JWeaver. No discussion. All present voted yea.
- Darke County Engineer's Office Invoice approval dated April 25,2025 cutting brush along Railroad Dr and Imler on 4/24/25 and 4/25/25 in the amount of \$2,691 and May 2, 2025 invoice for cutting trees along Imler Drive and brush cutting on East Drive on 5/2/25, Boom mower will finish East Drive next week (2hrs) in the amount of \$5,160.00. Motion approving payment of these invoices by JWeaver. All present voted yea.
- Resolution 2025-05- Authorizing Operating the Beach for the summer of 2025. Motion to waive 3
  reading rule by SHyatt. Seconded by REstes. All present voted yeah. Motion by SHyatt to make the
  Resolution an emergency; Seconded by CJeffers, all present voted yea.
- Darke County Parks 2025 Community Parks Improvement Grant Program Council Resolution for a Community Park Improvement Grant application to be submitted with two priorities defined (1) LED Signage and (2) Roads.
  - Project Priority 1 LED Community Message Sign; SHyatt motioned to set a match of \$3,500 towards this priority. Seconded by JWeaver. All Present voted yea.
  - Project Priority 2 Office parking area to be updated for handicap and senior accessible.
     JWeaver motioned to set a match of \$5,000 towards this priority. Seconded by CJeffers. All Present voted yea.
- Square 9 contact to not be renewed; end date if July 26,2025. Motion by SHyatt, Seconded by JWeaver. All
  present voted yea.
- Council seat SHyatt motioned to accept CWion's resignation effective May 20<sup>th</sup> from council. Seconded by LPrice, all present voted yea.
  - SHyatt motioned to install Jesse Valdez to this now vacant council seat. JWeaver seconded. All
    present voted yea.
  - o JValdez will receive Oath of Office at the next council meeting.
- Approved generator purchase for Sewer and Maintenance for the amount of \$325.00 take from Maintenance budget.
- Beach needs a push mower. Additional grounds equipment needed due to additional summer time hires.

- Laptops approval to increase appropriation for 4-laptopns by \$678.92 for a total purchase price of \$4,678.92 based on Quote from SignsourceIT. Motion by SHyatt. JWeaver second. All present voted yea.

- Ordinance inquiry shooting guns discussion sound is outside of Wayne Lakes Corporation. Mayor advised an
  ordinance can be defined not allowing any discharging of a weapon in Village limits. Issue is outside of Village
  limits. Recommended by SHyatt from prior experience is to speak with the landowner. Shooting and sound is
  outside of the Village limits. Noise ordinance is in place however the issue is occurring outside of Village limits.
