

Resolution No. 2026-05-18-001

A RESOLUTION AUTHORIZING THE SALE OF VILLAGE OF WAYNE LAKES FISHING PERMITS BY HANKS BAITS (BULLFROGS), 1054 MAIN DR, GREENVILLE OH AND DECLARING IT AN EMERGENCY.

WHEREAS, the Council of the Village of Wayne Lakes issues annual fishing permits for use on village-managed lakes; and

WHEREAS, the Village Council finds it beneficial to make fishing permits more accessible to residents and visitors by authorizing additional local vendor; and

WHEREAS, Hanks Baits (Bullfrogs), located at 1054 Main Dr., Greenville, OH, has requested authorization to sell official Village of Wayne Lakes fishing permits; and

WHEREAS, the Village Council has determined that Hanks Baits (Bullfrogs) is a suitable and convenient location for the sale of such permits.


NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Wayne Lakes, Darke County, Ohio:

- Hanks Baits (Bullfrogs), located at 1054 Main Dr., Greenville, OH, is hereby authorized to sell official Village of Wayne Lakes fishing permits for the current and subsequent permit years unless revoked by Council.
- The vendor shall follow all pricing, record-keeping, and reporting requirements established by the Village of Wayne Lakes.
- All funds collected from permit sales shall be remitted to the Village in accordance with procedures set
 - Daily permits -
 - Fiscal Officer will maintain a copy of the Tracking sheet with the permit number assigned to Hanks.
 - Hanks will record permits sold by the number assigned to the Daily permit. Each sold permit will be recorded on the defined Tracking sheet.
 - Monthly Hanks will provide a copy of the sold permit numbers, tracking sheet for reconciliation
 - Fiscal Officer will notify parties immediately of any discrepancies.
 - Card permits –
 - the Village will provide Hanks with the 2026 Fishing Permit application, to be completed and signed by the Purchaser.
 - Hanks will secure payment with application, provide Purchaser a receipt which will include the date the purchased permit will be available for pick up at place of purchase.
 - Hanks will provide the Permit applications with payment collected to the Village Fiscal Officer.
 - Fiscal Officer will print the card permit to complete the sale and return printed card to Hanks for delivery to the Purchaser.

- Fiscal Officer will complete reconciliation of the Sold/printed card permits to the forms and payments provided by Hanks; parties will be notified immediately of any discrepancies.

This Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, and safety, in order to ensure prompt availability of fishing permits at an additional vendor location. Therefore, this Resolution shall take effect and be in force immediately upon its passage.
